Meeting called to order at 17:00 by Supervisor Seguin.

Pledge of Allegiance

Attendance of Board: Present: Seguin, Mosher, Greene, West, Besey

Absent: None

**Agenda additions or corrections:** Mosher motion to approve as presented, Seguin second, no discussion, no opposition, motion carries.

**Special Meeting:** is opened by Seguin at 17:02. Mosher reads Written Charges regarding Shelley Greene. Greene protests stating the charges cannot be read at this time.

**Public Hearing:** is opened by Seguin at 17:03. Seguin asks Greene to step down from the board and offers her a seat in the audience. Greene refuses. Seguin states she into acting as a member of the Township Board and should not be at the board table. Greene remains. Mosher asks if the public or board would like the written charges regarding Shelley Greene read again at this time. Greene states she wasn't a closed session. Board informs public they will be in closed session and exit room to separate office area to conduct closed session.

17:39 Public hearing is reopened with Seguin inviting public to comment at this time, requesting each member addressing the board to stand and state name. Each member will be given 3 minutes (timed) to make comment. Seguin offers Greene the opportunity to speak first during public hearing or last. No response as Greene verbalizes opposition to conduct of meeting.

Irene Dunham-Thayer, Colfax Township-request to re-read the charges (Mosher reads charges again at this time)

Debra Franke, Village of Thompsonville-opposed to removal

Barb Hoseit, Colfax Township- opposed to removal

Debra Franke, Village of Thompsonville-believes this is a result of personality conflict of board members

Larry Sevegney-fully supports removal, cites personal experience

Tim Ranville, Colfax Township-supports removal, cites personal experiences

Greg Kraft, Colfax Township-supports removal, denies personal component to complaints

Shelley Greene-opposed to removal, states it is illegal, denies wrong-doing

Allyssa Holston, Village of Thompsonville-personal experience of intimidation by Greene

Tim Ranville-encourages moving forward (with replacement)

Public Meeting closed by Seguin at 10:04 after calling for and hearing no additional public comment

Shelley Green responds to comment of Ranville denying conflict serving as JPC member and zoning administrator, states she was appointed.

Irene Dunham-Thayer states ~~she~~ Greene volunteered for zoning administrator.

Seguin announces Special Meeting resumes at 18:06

Board discusses. Mosher makes a statement that this process was brought about by complaints from the public, whom the board serves, makes a motion to adopt resolution 2025-1 (read verbatim) to removed Green from the Colfax Thompsonville JPC effective immediately due to nonfeasance, malfeasance or malfeasance. Seguin seconds. No further discussion, roll call vote: YES: Seguin, Besey, Mosher, West, NO: None. ABSENT: None. (Greene is required to abstain)
